#### **Our Branch EOF Grant**

The reason I do fundraising for our Branch is that the money we bring in enables a broader community of women with a Bachelor's degree to gain access to educational and economic opportunities. Our Branch maintains Grant #1445 which was funded by Jamestown members from 1980 to 2002 for that purpose. It's our legacy to ensure that that fund continues to provide a substantial grant each year to a worthy woman or project.

National AAUW sifts through the applications to determine who receives the Grant. I have just discovered that our new grant recipient for 2015-16 is Nicole Patten from Fullstack Academy, New York, New York. Her field is computer and information sciences. Our grant will enable her to specialize in computer programming. I am in touch with National to learn more about her and will try to make contact with her to give you further information in the next TWIGS.

This is not the only grant available to women through AAUW. In fact, AAUW is one of the world's largest sources of funding for graduate women, providing more than \$3.7 million in funding for more than 241 grants and fellowships to outstanding women and nonprofit organizations in the 2015-16 academic year. I am including the following information in case you might want to apply for one.

<u>Career Development Grants</u> -- Who may apply: Women pursuing a certificate or degree to advance their careers, change careers, or reenter the workforce and whose bachelor's degree was received at least five years before the award period. Deadline: December 15. Funding: \$2,000-\$12,000

American Fellowships -- Who may apply: Women pursuing full-time study to complete dissertations, conducting postdoctoral research full time, or preparing research for publication for eight consecutive weeks. Deadline: November 15. Funding: \$6,000-\$30,000.

<u>International Fellowships</u> -- Who may apply: Women pursuing full-time graduate or postdoctoral study in the United States who are not U.S. citizens or permanent residents. Deadline: December 1. Funding: \$18,000-\$30,000.

International Project Grants -- Who may apply: Alumnae of AAUW's International Fellowships program who are living in their home countries and pursuing community-based projects to improve the social advancement and economic empowerment of women and girls. Deadline: January 15. Funding: \$5,000-\$7,000.

Selected Professions Fellowships -- Who may apply: Women pursuing full-time study in a master's or professional degree program in which women are underrepresented, including STEM, law, business, and medicine. Deadline: January 10. Funding: \$5,000-\$18,000.

Dream It Do It hosted "Women in Engineering" at Cummins Engine on October 20. Linda Fellows, Patty Lindquist, Alicia Hodnett, and Ruth Wahl from the STEM Team represented the AAUW. The event included a panel discussion from women in various occupations at the company. The women stressed the importance of reading and math in their jobs. Many of the women had come into their careers following non-traditional pathways. Many had changed jobs at Cummins by choosing additional training and receiving tuition reimbursement. All said that STEM careers are a way to make a good living in our local area.

About 20 mostly middle-school aged girls and their parents attended. The evening ended with a tour of the plant.

#### Circle of Distinction \_

Mehitable Wing Prendergast was the 4th woman honored by the Circle in 1985. Her historic horseback ride rivals Paul Revere's in the annals of the country's history. Mehitable married her husband, William Prendergast in 1755 and settled down to farm on a few acres of land William rented from Frederick Philipse, lord of thousands of acres in Westchester and Dutchess Counties.

William's crops had been poor; he was behind in his rent; and he was disturbed and unhappy about a number of things regarding Philipse's treatment of the tenants on his lands. He learned that Philipse paid the British crown the same amount of money for his vast estate that he paid to rent a few acres. Talking with other farmers, he learned all had the same problems and gripes and were willing and eager to demonstrate against all of the manor lords. He raised an army of

hundreds who marched through the area, rioting as they went. Many were arrested. William, who had escaped capture, gave himself up, at Mehitable's urging, to the authorities on charges of treason.

Mehitable stayed by his side at his trial, even speaking on his behalf. But, William was convicted of treason and sentenced to be hung. Mehitable immediately mounted a horse and rode 80 miles to the home of the Governor at Ft. George on Manhattan Island, begging for an audience with him. Her pleas so touched him, that he granted a stay of execution, pending a pardon from King George III. Mehitable immediately rode the 80 miles back home.

We know, of course, that the pardon was granted, and Chautauqua County's early history was sealed. Incidentally, Prendergast remained loyal to the King throughout the Revolutionary War.

The Chautauqua County League of Women Voters statistics paint a very dismal picture of the voting record of the County's residents. In a Presidential year, 2/3-3/4 of registered voters will make their voices heard via the ballot. In off-years, as few as 1/4-1/3 will take advantage of this opportunity to speak regarding the critical local issues which affect all county residents.

# **Education Partners Present Self-Defense Workshop**

Our Branch joined with our AAUW College Partner, Jamestown Community College (JCC), to present a self-defense workshop Wednesday at 6:30 p.m. in the JCC Student Union, Hamilton Collegiate Center. This event followed the continued focus on violence against women events presented by the AAUW and JCC coalition on women's issues. The event was free and open to the public.

Barry Swanson, JCC coordinator of campus safety and security, and Eileen Goodling, JCC vice president of student development, spoke about campus safety and Title IX. Renee Funke lead the program into the physical demonstration of self-defense. She is currently studying martial arts at AKT Combative Academy in Olean, where a high priority is placed on reality-based instruction and activities.

#### ICE 8 Unveiled to AAUW Jamestown Branch

Christine Schuyler, Chautauqua County public health director and social services commissioner, gave a presentation at our October Branch meeting, discussing the new Innovate Collaborate Educate 8 (ICE 8) initiative. All 18 school districts in the county have signed on to this collaborative program which focuses on health education; physical education; health services; nutrition services; counseling, psychological and social services; a healthy and safe school environment; health promotion for staff; and family and community

involvement. She said: "It takes a whole county to raise a whole child."

"Right now, 50 percent of our community can't pass a drug test," Schuyler said. "Obviously, what we have been doing for years and years isn't working. Every facet is affected by this. If you want to get rid of the fighting, school suspensions and get better graduations rates, we need a more comprehensive program," Schuyler said."We need to do something as early as we can. We can only do so much for the adults, and we need to start doing something for the next generation."
