- We are operating well within our budget

- The Fenton History Center is considering giving a free one month membership to AAUW members.
 Final proposal not complete yet may include a tour and possible program.
- Linda Fellows prepared two Legal Advocacy Fund baskets for the AAUW NYS Convention.
- Linda Fellows chaired the Nominating Committee.
 Offices to be filled included: President (one year term), Treasurer, Educational Opportunities Fund VP, and Program VP (two year terms)

Scholarship Recipients Honored and an Incredible Panel of Leaders Presented

What an amazing night, April 30, 2015 at our branch Membership Social where AAUW Jamestown Branch honored 15 scholarship recipients and enjoyed a panel conversation by three dynamic female leaders!

The evening started off by celebrating our scholarship winners. Wendy Present, scholarship committee chair, and Kathi Clark, scholarship committee member, presented roses and told of each winner's accomplishments.

To qualify for the scholarships, the women had to have a minimum GPA of 3.5, be graduating with an associate's degree, and be accepted into a bachelor's program. Each of these women also demonstrated leadership qualities, community service, work experience, and career goals, and they were active participants on their college campuses and had overcome some challenges.

Following the scholarship honors, the speakers began their conversation. This amazing panel of female leaders included Dr. Lillian V. Ney; Katie Geise, executive director of the Workforce Investment Board; and Tory Irgang, executive director of the United Way of Southern Chautauqua County. They discussed women in leadership and what that means.

The conversation emphasized that we need to empower each other and offer a hand to each other as women instead of competing against each other. We need to be mentors to each other. Geise said, "The best way to mentor someone is to listen and care about her next step. True compassion is necessary. You have to be in it because you care about that person."

Irgang expounded on that idea, saying "sometimes that means offering to open a door for someone. Sometimes that can mean making a phone call, but it is essential that we don't create barriers for anyone to succeed."

Dr. Ney wrapped up the discussion by saying, "We have a long way to go, and if we don't support one another, we won't see the world we wish to create."

(Over the years, AAUW Jamestown Branch has awarded over \$450,000 to over 400 women pursuing their four-year degrees.)

Public Policy —

AAUW's Public Policy program is beginning to sound like a broken record. The major focus remains Pay Equity - the difference between the average earnings of men and women. The difference varies from state to state throughout the US. (The percentages quoted reflect what women are paid, ie, 78% of what men are paid.) Washington, DC, not surprisingly, has the best record - 91%. New York State is second with 86%. From there the percentage goes down to the lowest, 66%, held by Louisiana. It all averages out to 78% for the entire country.

In general, there is no significant difference between genders - 73% to 79% - when taking into account the level of education: less than high school = 76%; doctoral degree = 79%. The great disparity here, of course, is in the amount of the earnings at the various educational levels.

This is not true when comparing the discrepancy by age. The difference for teenagers is 90%, but it lowers steadily during the working years, and at retirement of 65 or older the difference is 74%. In other words, in retirement women are receiving 74% of what men are receiving.

The other interesting comparison is in race/ethnicity. Hispanic women earn 90% of men's earnings. For African-Americans the disparity is 91%. In the "white" population women earn 78% of what men

earn. These percentages point out the great difference in the male population's earnings, with minority men earning considerably less than "white" men.

Pay equity is an ethical issue. People performing the same or very similar work should be paid the same, regardless of gender. Lily Ledbetter made that very clear and the US Supreme Court agreed with her, awarding her millions of dollars, which she never did receive.

It is also an economic issue. Women, in general, are the shoppers. Put money in a woman's pocket, she will spend it on consumer goods of all kinds for her family and her home. This in turn, requires more goods to be produced, putting people to work to make those goods . . . a win/win situation for the US economy if we can continue to produce those goods in the US.

Also, women tend to live longer than men, requiring care in specialized facilities for the frail elderly. Without sufficient personal financial resources, family and society at large must pick up the difference for their care. Higher retirement incomes, generated from higher working incomes, will lower that cost. Again, pay equity is an economic issue.

AAUW will continue to make pay equity a priority in its overall Public Policy program.

Circle of Distinction

In our Jan/Feb issue we recounted the extraordinary accomplishments of Kate Stoneman, a member of that remarkable Lakewood area family. This issue will feature another female member whose circumstances took her to South Africa. The CoD recognized Bertha Stoneman in March 1987.

Bertha was born August 18, 1866 in Lakewood, a daughter of Kate's brother Bryan. She graduated from Jamestown High School in 1885, when secondary education for women was still uncommon. She enrolled in Cornell University, taking 9 years to acquire her bachelor of pedagogy degree, as she needed to work her way through by teaching school. She completed her D.Sc - doctor of science in botany - 2 years later. In 1897, she was invited to join the staff of the Huguenot College in Wellington, South Africa and was put in charge of the botany department. It should be noted she found no suitable employment in the US.

By 1905 Dr. Stoneman had built up a large and well-stocked herbarium and botany laboratory. Deeply involved in botanical research, she published *Plants and Their Ways in South Africa* in 1906. It became the standard text in South Africa and was reprinted 3 times. In 1921 she was appointed the 3rd president of the College. During this time, she was instrumental in the founding of the South African Association of University Women and in 1923 became its first president.

In addition to her executive ability and talent for teaching, Dr. Stoneman had extraordinary rapport with her students. She was a friend as well as a teacher, taking them with her on field expeditions and walking and picnicking with them. Her home at Bainskloof was available when she was not in residence. Many students spent happy holidays as well as weekends at "Stonemansion." Many of her stu-



dents became life-long friends and one of them, Lily Daws, cared for her during her last years of illness.

Dr. Stoneman was keenly interested in sports at the college and gave money generously for athletic facilities. She also helped indigent students. She had a talent for composing verse and published a book of verse, some of it on the whimsical side. She translated poetry from Afrikaans to English and had a great love of fun and laughter to the end of her life.

Dr. Stoneman died April 30, 1943 at her home in Bainskloof. Her funeral, held in the Dutch Reformed Church, was conducted by ministers of several denominations and attended by a long list of dignitaries. Her ashes remained in South Africa until the close of WW II when they were returned to the family plot in Bentley Cemetery in Lakewood.

Dr. Stoneman is still revered in South Africa and one of the most prestigious academic awards has been the Bertha Stoneman Fellowship for Botanical Research, now named the Bertha Stoneman Memorial Award. It is administered by the SAAUW and presented to a member who is pursuing a Master's or higher degree in botanical research.
